General Project Status

This project report reviews the Terrace Lakes ECWAG Project monthly progress and outlines action items required to meet overall project objectives. Budgetary and financial analysis on the project will be presented to Terrace Lakes Water Company (TLWC) Board on a routine basis. The progress report will be sent to Dennis Largent monthly and presented to TLWC Board as requested.

Project Objectives: Drill and equip a new groundwater source of supply to replace declining capacity in Well No. 5 associated with March 2020 earthquake.

Project Phasing:

The project will be completed in-line with the following phases:

Phase 1: Obtain Regulatory Approvals

- Complete IDWR Transfer Application to add new POD to existing water rights.
- Obtain Easement/Lease Agreement with Terrace Lakes Recreation Ranch LLC
- Idaho Power Company Agreement for Service Upgrades
- Execution of Easement/Lease Agreement (legal counsel approval)

Phase 2: Well and Facility Design

- Complete IDEQ Well Site Evaluation and Well Preliminary Engineering Report
- Complete IDEQ Facilities, Transmission, and Controls Preliminary Engineering Report
- Obtain IDEQ Construction Approval for Well No. 7 and associated Facilities

Phase 3: Facility Construction

- Phase 3a: Well Drilling, Production Testing, Water Quality Sampling
- Phase 3b: Facility Construction Commissioning, Startup and Testing

Phase 4: Project Closeout

- Well Completion Report
- Operation and Maintenance Manual
- As-built Drawings
- Engineer of Record Certification
- IDEQ Request to Serve Public

Mountain waterworks

Work Completed To Date (Since Last Progress Report)

A summary of work completed by Mountain Waterworks through the month of November 2021 is provided below.

- Century West Engineering (Trindera) was put under contract November 8th.
- Project kickoff with Givens Pursley LLP, Michael Lawrence (Thomas Dvorak unable to attend), on November 9th.
- IDEQ issued construction approval on Well No. 7 Plans and Specifications on November 9th.
 - o Cannot bid well without water right transfer approval and well site easement.
- Base civil and mechanical files sent to Keltic Engineering and Century West Engineering November 12th.
 - Civil and mechanical design is approximately 90-95% complete.
- Sawtooth Land Survey conducted field work on November 15th.
- The Well No. 7 Facilities PER was submitted to IDEQ on November 18th.
- Idaho Department of Water Resources reviewed the Water Right Transfer and was put on public notice December 1st.
 - December 20th is the last day for public protest.

Work In Progress:

- Water right transfer
- Well site easement.
 - Waiting on metes and bounds from Sawtooth (mid-December)
 - Tim Farrell and Rolly Woolsey to meet with Terrace Lakes Recreation Ranch.
- Send Well No. 7 out for quotations pending approval of water right transfer and well site easement.
- IDEQ review of Well No. 7 Facilities, Transmission, and Controls PER.
- Well No. 7 Facilities, Transmission, and Controls Structural design.
 - To be ready for MWW review end of December.
- Well No. 7 Facilities, Transmission, and Controls Electrical design.
 - 75% complete by end of December
